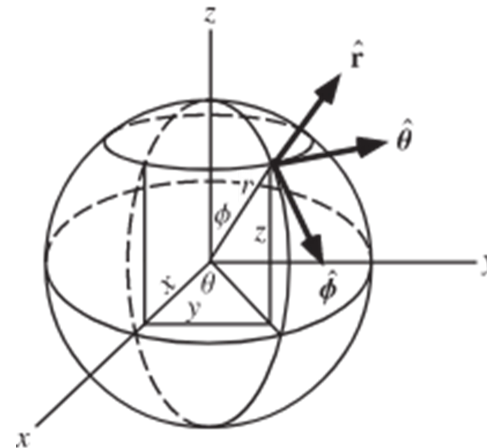
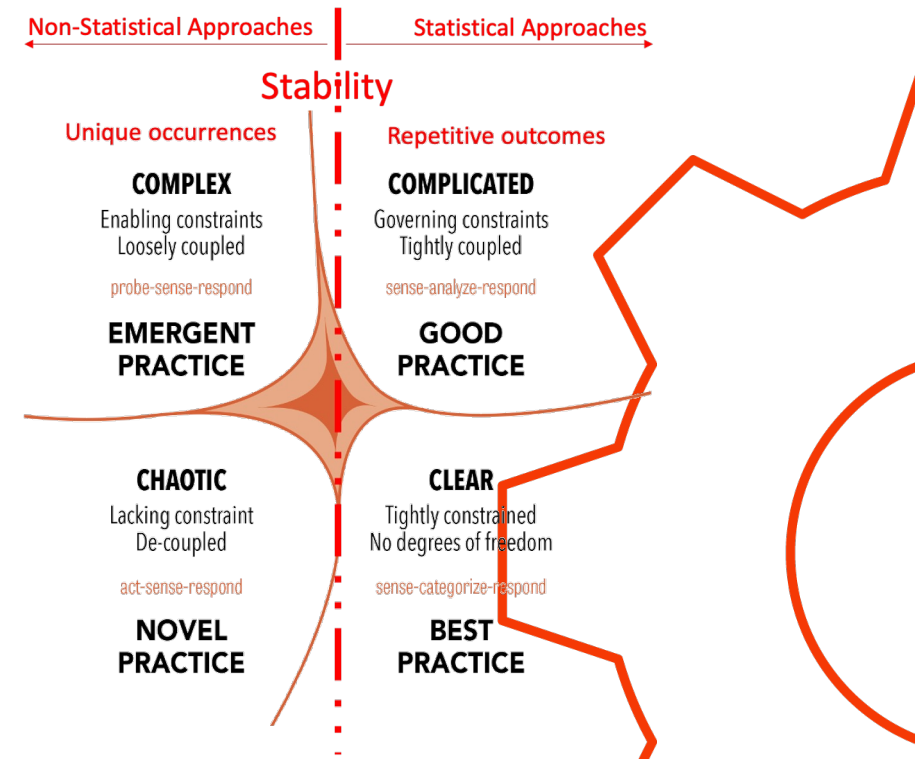
Impact on risk assessment

Universe of potential outcomes is unknown

- Probability is unknowable
- Physics-envy

Statistical basis is moot
- can't use a risk register

Impact on test point matrix

Massive (unachievable) number of test points

- Emergent behaviour – what to test?
- Unknowable – what baseline performance?
- Prior testing invalid for future configuration



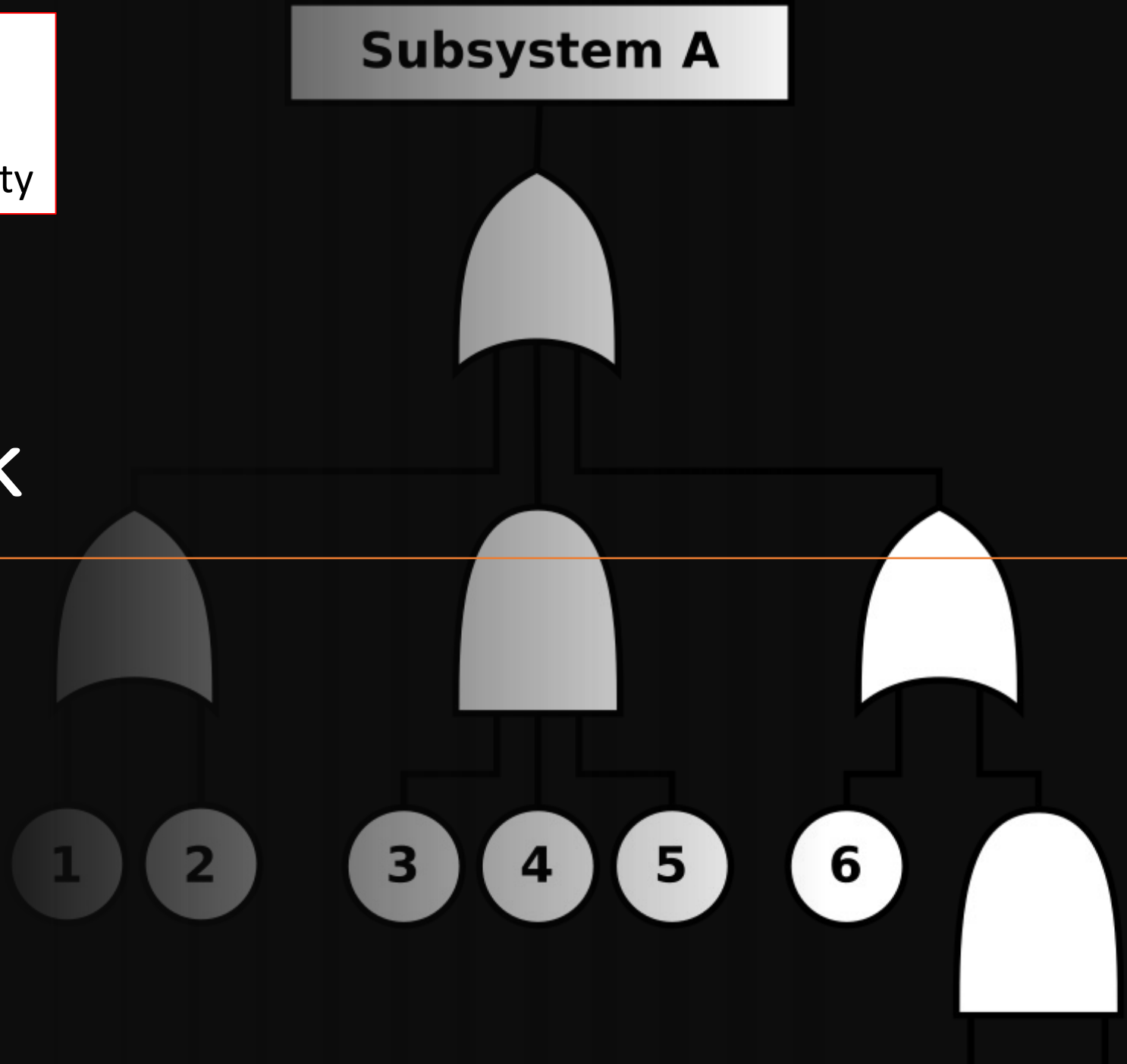
